SUBJECT: -Extension of General Affiliation up to Secondary Level.

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 10. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	As per application and Land certificate school is running on 6176 sq mtrs of land. However, in the fire safety certificate, land area is mentioned as 2444.67 sq mtrs. Thus, the school is required to submit the revised fire safety certificate with corrected details within 03 months and submit the compliance.
3	The land certificate is not as per the prescribed format and it was issued in 2020. Further, land title / ownership of the lessor is not mentioned in the same. Thus, the school is required to obtain renewed land certificate as per format i.e. appendix - X as prescribed in circular no. 12/2022 within 03 months and submit the same in the compliance.
4	The school is required to obtain water test report of the school from a Govt. authorized laboratory within 03 months and submit the same in the compliance.
5	The computer lab has only 16 computers which are less than minimum requirement i.e. 40 computes. Thus, the school is required to procure more computers within 03 months and submit the invoice along with videography in the compliance.
6	The composite science lab has side slabs, adjacent to the wall, which is not appropriate for conducting practical. There is a temporary make-shift tables arranged for physics. Further, It does not have sufficient number of washbasin (with water tap) as well as gas connection in the workstation and exhaust fan. Thus, the school is required to set-up as per Board's SoP within 03 months and submit the compliance
7	The mathematics lab is under stocked and temporarily arranged with insufficient storage and no seating facility. Thus, the school is required to upgrade the same as per Board's SoP within 03 months and submit the compliance.
8	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. Further, few CwsN toilets have raised entrance, which is not suitable for wheelchair bound students. Thus, the school is required to construct the CwsN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat.

(fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.

9 The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
